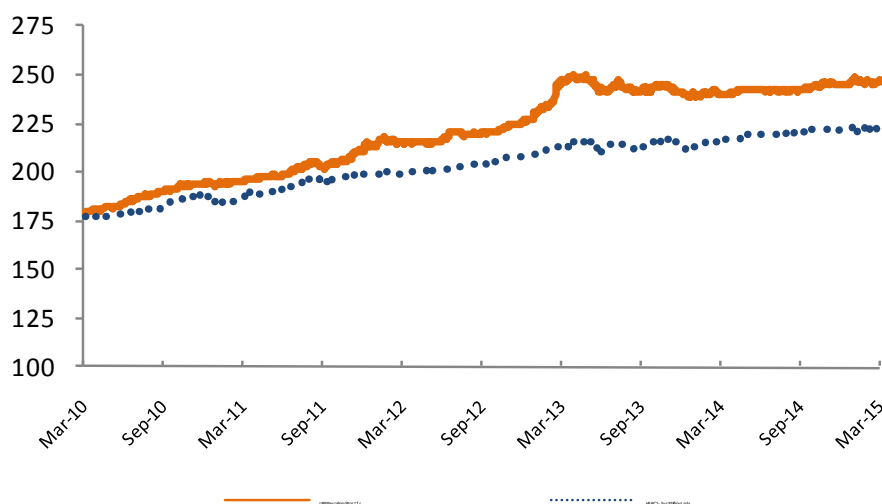

#### Net Asset Value per Unit

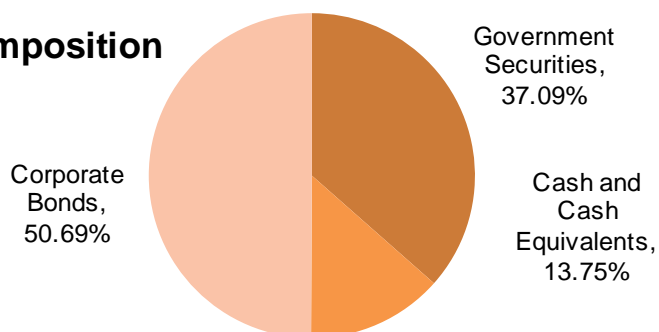
