## CLIENT SUITABILITY

Some of the key risks associated with this Fund are listed below:

- **Market/Price Risk:** Possibility to experience losses due to adverse changes in market prices of securities

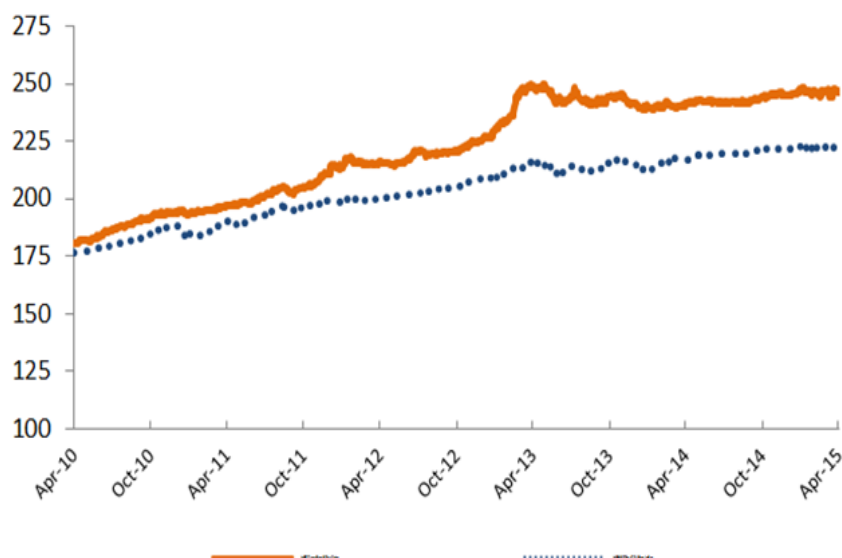

### NAVPu Graph

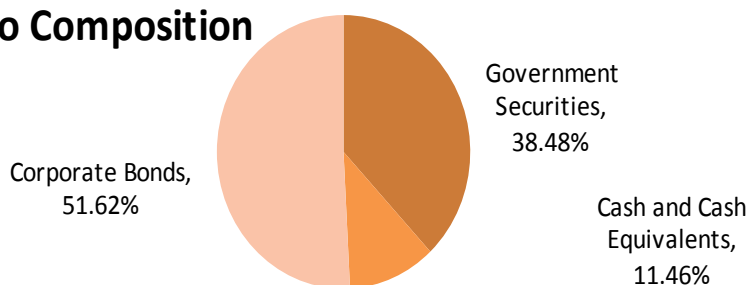
