INVESTMENT OBJECTIVE AND STRATEGY

The UnionBank Philippine Peso Fixed Income Portfolio is a peso-denominated bond fund designed to provide investors higher returns than traditional fixed-income savings products.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- The UnionBank Philippine Peso Fixed Income Portfolio is suitable only for investors who:
 - Are individuals of legal age and corporations with a medium to long-term investment horizon
 - Have a moderately conservative risk profile

Some of the key risks associated with this Fund are listed below:

- **Interest Rate Risk:** This is the possibility to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.
- **Market/Price Risk:** This is the possibility to experience losses due to adverse changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

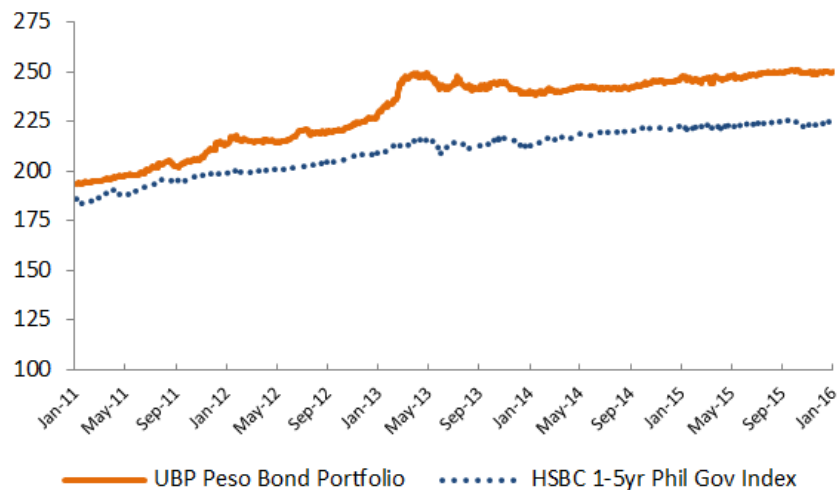

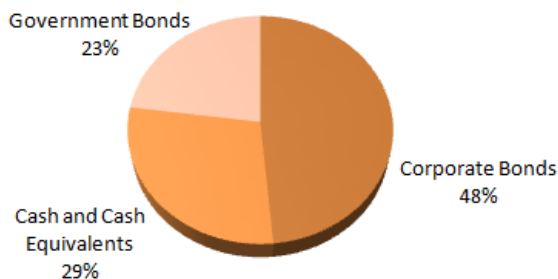

RELATED PARTY TRANSACTIONS

The fund has bond investments with Aboitiz Equity Ventures amounting to Php 38.95 Mn. This investment outlet was approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

The local bond market proved resilient amidst a global risk off sentiment. With a massive PHP87 billion maturing by the end of the month(FXTN 7-48), client driven buying initiated to pull down yields on the short end of the curve. Most of the buying activity was below the 5 years tenor while the rest of the curve remained quiet. After a successful re-issuance of FXTN 10-60, market started to sell off the belly and the long ends as the yield curve steepened. However, as the month nears its end, liquidity spilled over to the belly and the long ends. The month of January saw how resilient the GS market was compared to its peers being supported by awash liquidity. However, it also experienced flashes of risk off sentiment as it tracked the drop in US treasury yields and the drop of oil in the global market. In addition to the uncertainty, details of the Interest Rate Corridor remains unclear which might cause volatility especially in the short end of the curve.
