INVESTMENT OBJECTIVE AND STRATEGY

The UnionBank Philippine Peso Fixed Income Portfolio is a peso-denominated bond fund designed to provide investors higher returns than traditional fixed-income savings products.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- The UnionBank Philippine Peso Fixed Income Portfolio is suitable only for investors who:
 - Are individuals of legal age and corporations with a medium to long-term investment horizon
 - Have a moderately conservative risk profile
- The principal is at risk. Loss in the original investment may arise due to market fluctuations and price volatility of the securities held by the fund.

KEY RISKS AND RISK MANAGEMENT

Some of the key risks associated with this Fund are listed below:

- **Interest Rate Risk:** This is the possibility to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.
- **Market/Price Risk:** This is the possibility to experience losses due to adverse changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

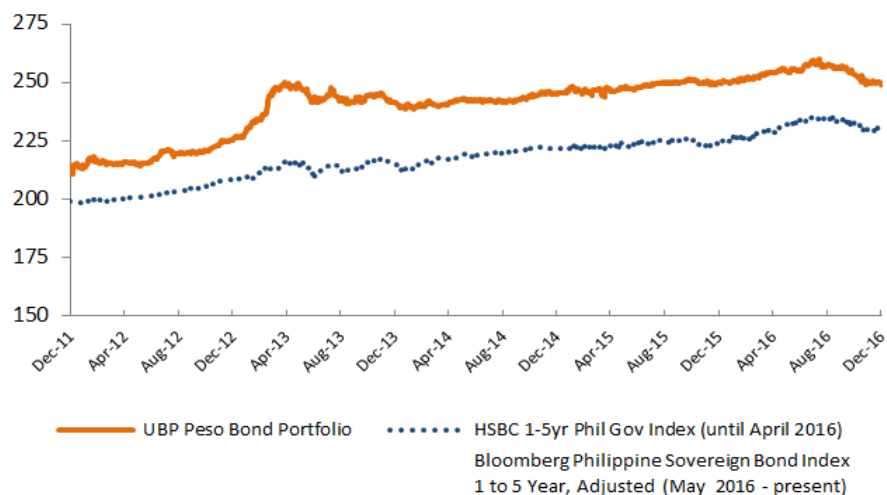

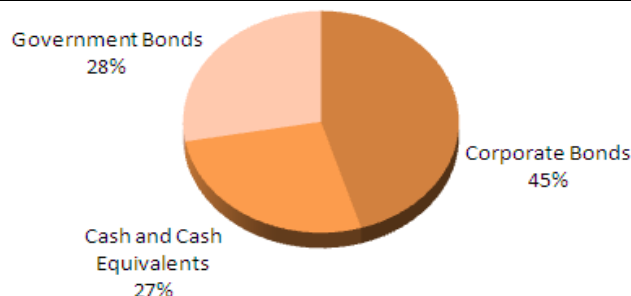

RELATED PARTY TRANSACTIONS

The fund has bond investments with Aboitiz Equity Ventures and time deposits with City Savings Bank amounting to Php 38.68 Mn and Php 263.57 Mn, respectively. These investment outlets were approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

BTR announced 1st quarter borrowing 2017 schedule with increased borrowing. Treasury bills planned offer increased Php 30B to Php 90B against the 1st quarter of 2016 while treasury bonds increased Php 15B to Php 90B against the same period. Php 30B will be issued every month with only 3yr and 5 yr tenors for the treasury bonds.

Inflation for December 2016 came in line with market expectations at 2.6% which is still within BSP's forecast of 2.2% to 3%. The moderate rise in inflation for December eased concerns on a steeper rise that may spur our central bank to action as projected by some analysts.

The peso bond market rallied after BTR's announcement of the 1st quarter borrowing schedule. Though bigger in terms of scheduled borrowing volume, the tenor of the bonds for auction was limited to 3 years and 5 years. Peso bond rally was sparked by FXTN 10-60 (8.67yrs) with yields going down to as much as 50 bps which later on spilled over to the rest of the curve. Lower US benchmark yields combined with high local liquidity and moderately rising inflation enticed the market to take on local credit as we start the year.
