**INVESTMENT OBJECTIVE AND STRATEGY**

The UnionBank Dollar Bond Portfolio is a US Dollar-denominated bond fund designed to provide investors with higher returns than traditional fixed-income savings products. Earnings volatility is kept at moderate levels, through disciplined investment selection and tenor diversification.

**CLIENT SUITABILITY**

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- The UnionBank Dollar Bond Portfolio is suitable only for investors who:
  - Are individuals of legal age and corporations with a medium to long-term investment horizon
  - Have a moderately conservative risk profile

Some of the key risks associated with this Fund are listed below:

- **Interest Rate Risk:** This is the possibility to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.
- **Market/Price Risk:** This is the possibility to experience losses due to adverse changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

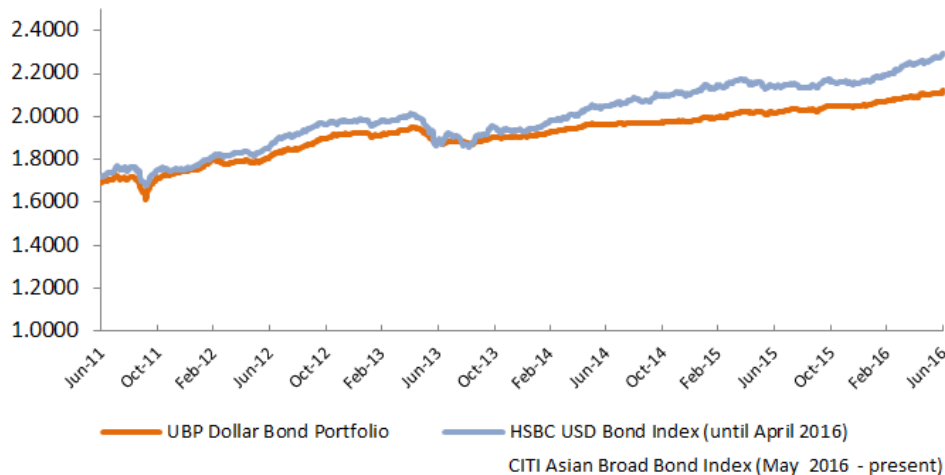

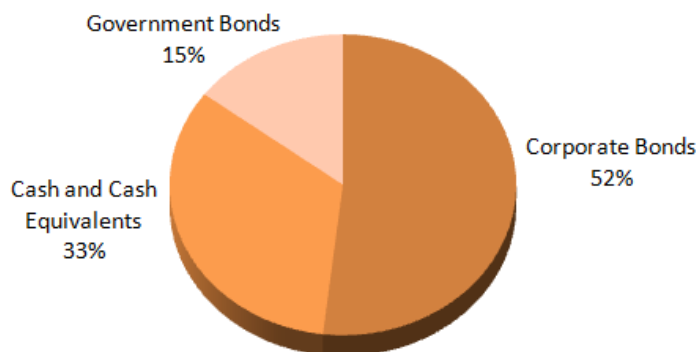

**RELATED PARTY TRANSACTIONS**

The fund has time deposits with UnionBank of the Philippines amounting to USD 1.42 Mn. This investment outlet was approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

**OUTLOOK AND STRATEGY**

Surprising results from the United Kingdom referendum made "Brexit" a reality as it heightened uncertainty across the financial markets. Initial post-referendum market painted a risk-averse scenario as bid offers remained wide. However, the bond market jump started its steep rally in anticipation of more stimulus from central banks. ROP's followed the big rally in US treasury yields as prices continued to soar as investors began the hunt for yield. ROP 41 reached as high as 112 (3%) as UST 10 yr reached the lows of 1.40% levels. The month of June was all about global growth risk aggravated by the Brexit, political instability and terror attacks. With this in mind, we will continue to see UST yields to trend low and hit historic lows as market players hunt for yields.
