INVESTMENT OBJECTIVE AND STRATEGY

The UnionBank Dollar Bond Portfolio is a US Dollar-denominated bond fund designed to provide investors with higher returns than traditional fixed-income savings products. Earnings volatility is kept at moderate levels, through disciplined investment selection and tenor diversification.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- The UnionBank Dollar Bond Portfolio is suitable only for investors who:
 - Are individuals of legal age and corporations with a medium to long-term investment horizon
 - Have a moderately conservative risk profile

Some of the key risks associated with this Fund are listed below:

- **Interest Rate Risk:** This is the possibility to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.
- **Market/Price Risk:** This is the possibility to experience losses due to adverse changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

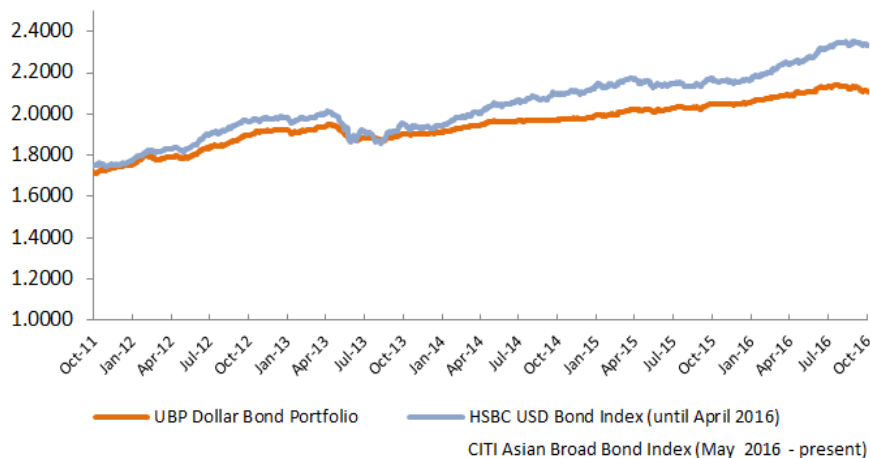

Net Asset Value per Unit

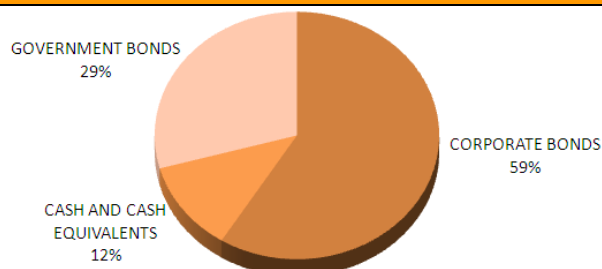

RELATED PARTY TRANSACTIONS

The fund has time deposits with UnionBank of the Philippines amounting to USD 633,949.84. This investment outlet was approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

The United States economy expanded an annualized 2.9 percent in the third quarter of 2016, more than 1.4 percent in the previous quarter and beating market expectations of a 2.5 percent rise. The Federal Reserve left the target range for its federal funds rate unchanged at 0.25 percent to 0.5 percent for the seventh time during its November 2016 meeting. It cited the continued strengthening of the labor market and the further improvement on growth of economic activity. Policymakers also added that the case for an increase in the federal funds rate has continued to strengthen.

ROP space continued to trade weak as emerging market credit underperformed in general. ROP 41's were hit the most and has reached 103.75 (3.47%) vs 110.279(3.097%). Most of the sellers remained to be foreign while local players shifted to the shorter tenors. UST 10 year yields were also higher and reached 1.8% from 1.57% a month ago. Market is currently pricing in a 78% probability of a rate hike in December. Elections and NFP releases will be closely monitored as continued nervousness persists ahead.
