**INVESTMENT OBJECTIVE AND STRATEGY**

The UnionBank Dollar Bond Portfolio is a US Dollar-denominated bond fund designed to provide investors with higher returns than traditional fixed-income savings products. Earnings volatility is kept at moderate levels, through disciplined investment selection and tenor diversification.

**CLIENT SUITABILITY**

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- The UnionBank Dollar Bond Portfolio is suitable only for investors who:
  - Are individuals of legal age and corporations with a medium to long-term investment horizon
  - Have a moderately conservative risk profile

Some of the key risks associated with this Fund are listed below:

- **Interest Rate Risk:** This is the possibility to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.
- **Market/Price Risk:** This is the possibility to experience losses due to adverse changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.
- **Liquidity Risk:** This is the possibility to experience losses due to the fund's inability to sell and convert assets into cash immediately or in instances where conversion to cash is possible but at a highly disadvantageous price.

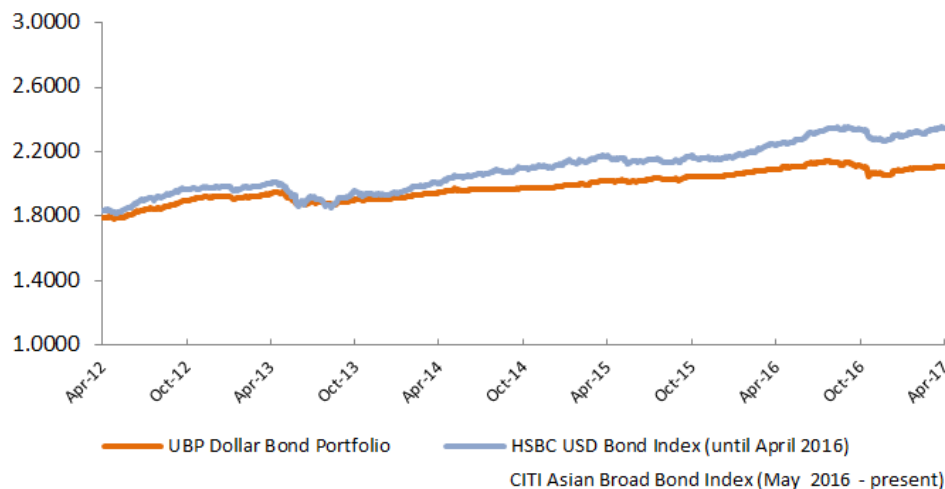

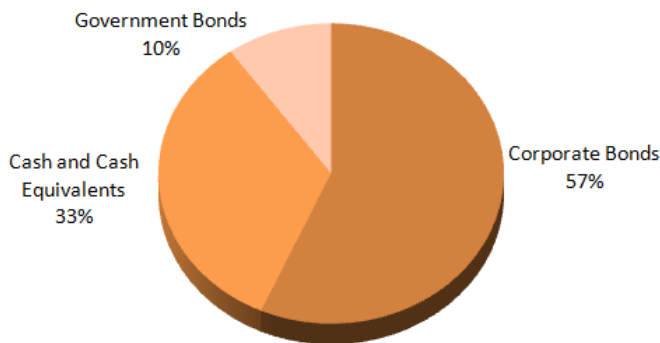
\*Volatility measures the degree to which the Fund fluctuates vis-a-vis its average return over a period of time.

**RELATED PARTY TRANSACTIONS**

The fund has time deposits with UnionBank of the Philippines amounting to USD 1.00 Mn. This investment outlet was approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

**OUTLOOK AND STRATEGY**

After the FED's first hike of the year, the month of April served as a relief for rising yields as markets responded to uncertainties by shifting to safe haven assets. Geopolitical concerns with US-Syria and US-North Korea, French elections, concerns on US government deadlock and disappointing Q1 US GDP growth boosted demand for US treasuries. With these events fueling risk off sentiment, the 10 year US benchmark reached as low as 2.30%. ROP bond prices continued to post gains of 0.7pts-0.9pts across the liquid securities as market players re-priced a delay in FED fund rate hike for its June meeting.

As Geopolitical tensions fade, market will tend to focus again on what the Fed has to say regarding the GDP numbers and other soft data that came out. Uncertainties caused by developments on Trump policy details will cause more volatility ahead. Staying defensive or maintaining a cautious stance will be a safe bet in the months to come.
