INVESTMENT OBJECTIVE AND STRATEGY

The UnionBank Dollar Bond Portfolio is a US Dollar-denominated bond fund designed to provide investors with higher returns than traditional fixed-income savings products. Earnings volatility is kept at moderate levels, through disciplined investment selection and tenor diversification.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- The UnionBank Dollar Bond Portfolio is suitable only for investors who:

Some of the key risks associated with this Fund are listed below:

- **Interest Rate Risk:** This is the possibility to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.

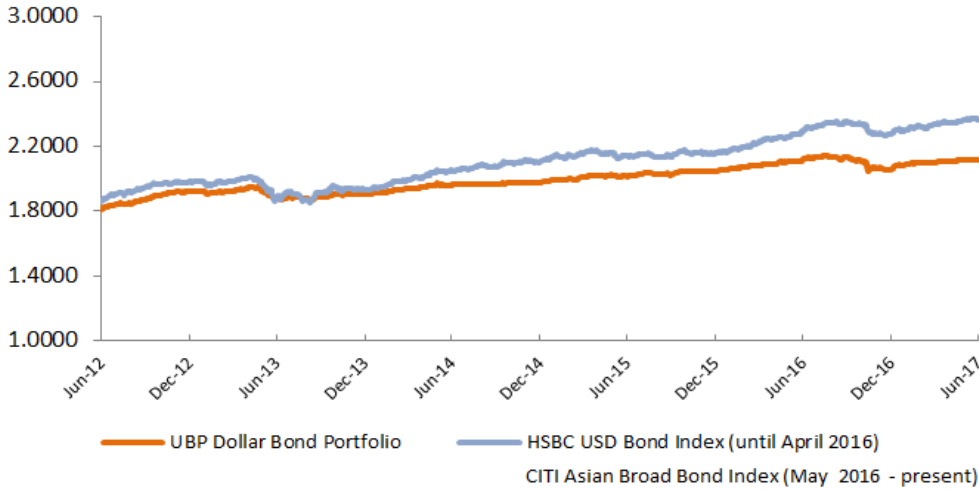

Net Asset Value per Unit

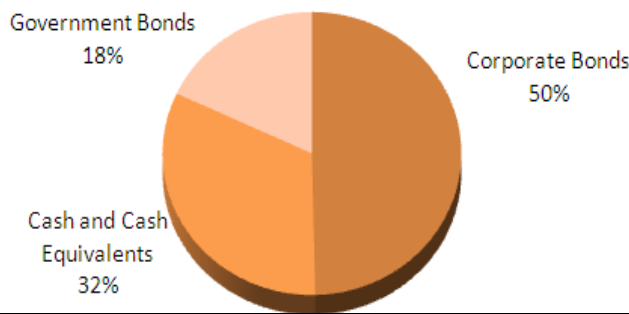

RELATED PARTY TRANSACTIONS

The fund has time deposits with UnionBank of the Philippines amounting to USD 1.15 Mn. This investment outlet was approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

As widely expected, the Federal Reserve hiked federal funds rate by 25bps to 1.25% mid half of June. The Fed kept its forecasts for one more rate hike for 2017 while increasing growth projections and lowering inflation expectations. The Fed also touched on the details on the balance sheet reduction. Reaction was muted until ECB and BOE surprised markets by perceived hawkish policy direction statements. Bond indices fell as yield rose with higher expectations of future rate hikes.

US 2 year and 10 year treasury yields rose almost 20bps from 1.28 to 1.48% and from 2.10% to 2.31%. US 30 year treasury yields ended flat for the month at 2.86%. Emerging markets followed suit as ROP prices fell. ROP 2042's, the most liquid part of the curve fell from the month's high of 103 (3.51%) to 101 (3.63%). With sellers emerging in the ROP bond market space, we remain defensive and cautious preferring the short dated ROP's and corporate bonds.
