INVESTMENT OBJECTIVE AND STRATEGY

The UnionBank Dollar Bond Portfolio is a US Dollar-denominated bond fund designed to provide investors with higher returns than traditional fixed-income savings products. Earnings volatility is kept at moderate levels, through disciplined investment selection and tenor diversification.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

- The UnionBank Dollar Bond Portfolio is suitable only for investors who:
 - Are individuals of legal age and corporations with a medium to long-term investment horizon
 - Have a moderately conservative risk profile

Some of the key risks associated with this Fund are listed below:

- **Interest Rate Risk:** This is the possibility to experience losses due to changes in interest rates. The purchase and sale of a debt instrument may result in profit or loss because the value of a debt instrument changes inversely with prevailing interest rates.
- **Market/Price Risk:** This is the possibility to experience losses due to adverse changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.

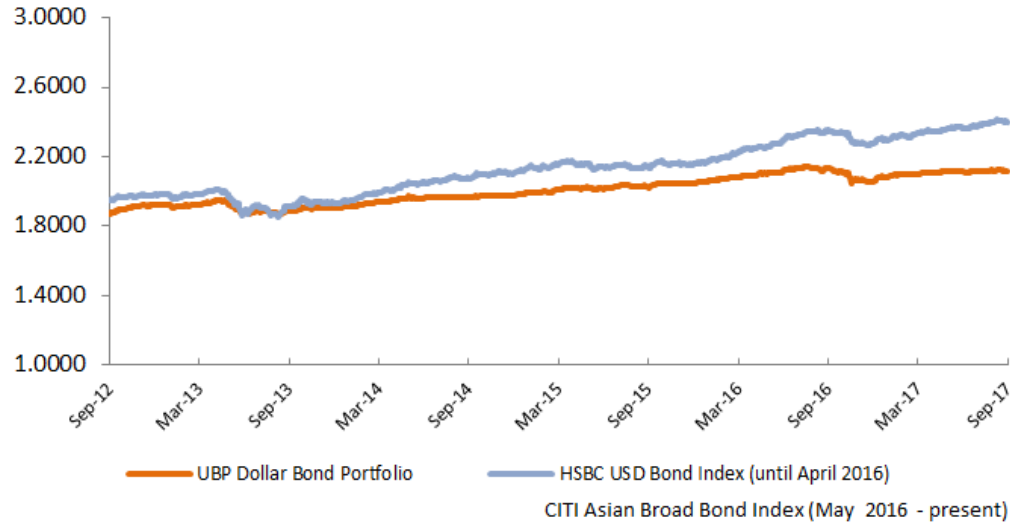

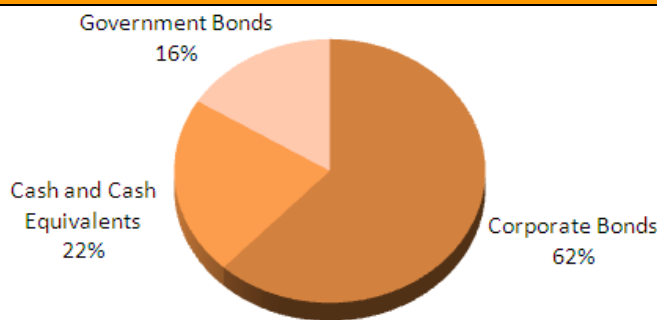

RELATED PARTY TRANSACTIONS

The fund has time deposits with UnionBank of the Philippines amounting to USD 1.0 Mn. This investment outlet was approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

US benchmark yields once again surged north as market players priced in a December rate hike. Hawkish comments from Philadelphia FED president Harker and reports on US president Donald trump and Treasury Secretary Steven Mnuchin meeting with former Federal Reserve Governor Kevin Warsh (a critic of stimulus policies) sparked the rise of yields with UST 10 year benchmark reaching as high as 2.40% before settling at 2.35%. This dragged ROP prices down almost 75-100 pips across the curve. ROP prices remained better offered for the most part while Philly corporate bonds saw two way interest with interest mostly on the short dated MEG 2018 and RCBC 2020. With some FED speakers generally inclined to a December rate hike due to recent upbeat economic data, we prefer staying on the sidelines as market overshoots and open an opportunity for bottom fishing.
