INVESTMENT OBJECTIVE AND STRATEGY

The UnionBank Dollar Bond Portfolio is a US Dollar-denominated bond fund designed to provide investors with higher returns than traditional fixed-income savings products. Earnings volatility is kept at moderate levels, through disciplined investment selection and tenor diversification.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Some of the key risks associated with this Fund are listed below:

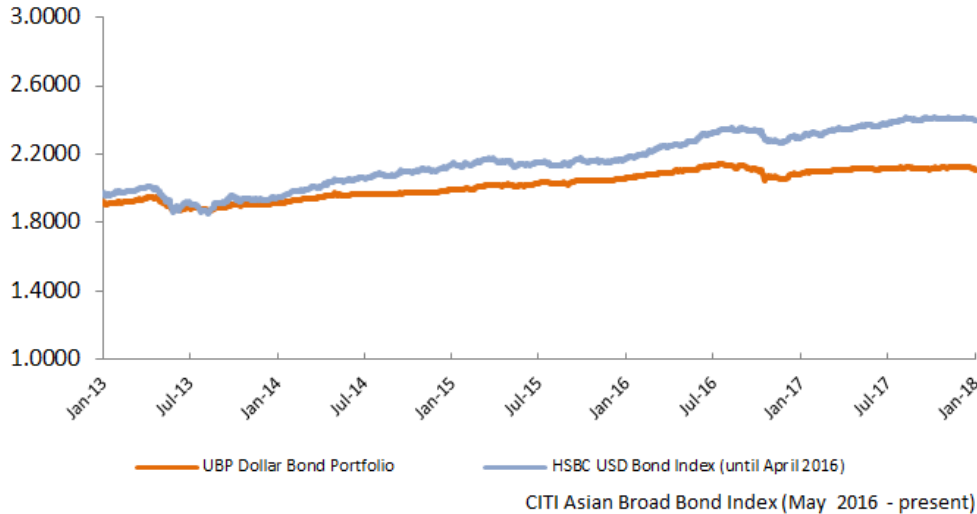

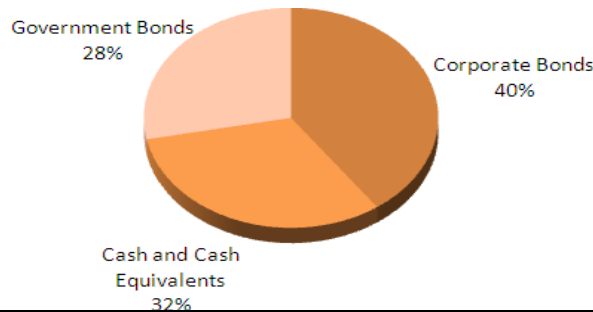

RELATED PARTY TRANSACTIONS

The fund has time deposits with UnionBank of the Philippines amounting to USD 792,136.81. This investment outlet was approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

The Federal Reserve held short-term interest rates steady at 1.5% during its January 2018 meeting. The FED said it would continue along its path of gradual increases aimed at keeping the economy on track. Official statement also noted the solid gains in employment, household spending and business fixed investments and that near-term risks to economic outlook appear roughly balanced. Market analysts continue to expect 3 to 4 hikes in total for 2018 with the earliest this March. Last FOMC meeting will be the last for Chairwoman Janet Yellen before she turns over to Fed Governor Jerome Powell.

US treasuries have risen sharply in January with generic 10 year bonds climbing as high as 2.71% from 2.40%. The strong jobs report strengthened expectations of an earlier rate hike in the first quarter. Meanwhile, Philippine government had a tender offer for new 10 year issuance maturing 2028. ROP 28 was priced at 3.0% with existing holders of eligible bonds can either switch into the new 10 yr or tender for cash. Initially, the new 10 year traded tightly before succumbing to UST benchmark sell offs. Price fell at the onset in the secondary market to 97.875 and ended 96.625 by the end of January. With benchmark 10 year US treasuries climbing roughly 30 basis points, we stay cautious and maintain a short duration for our portfolios given that the next resistance would be at 3%.
