**INVESTMENT OBJECTIVE AND STRATEGY**

The UnionBank Dollar Bond Portfolio is a US Dollar-denominated bond fund designed to provide investors with higher returns than traditional fixed-income savings products. Earnings volatility is kept at moderate levels, through disciplined investment selection and tenor diversification.

**CLIENT SUITABILITY**

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. 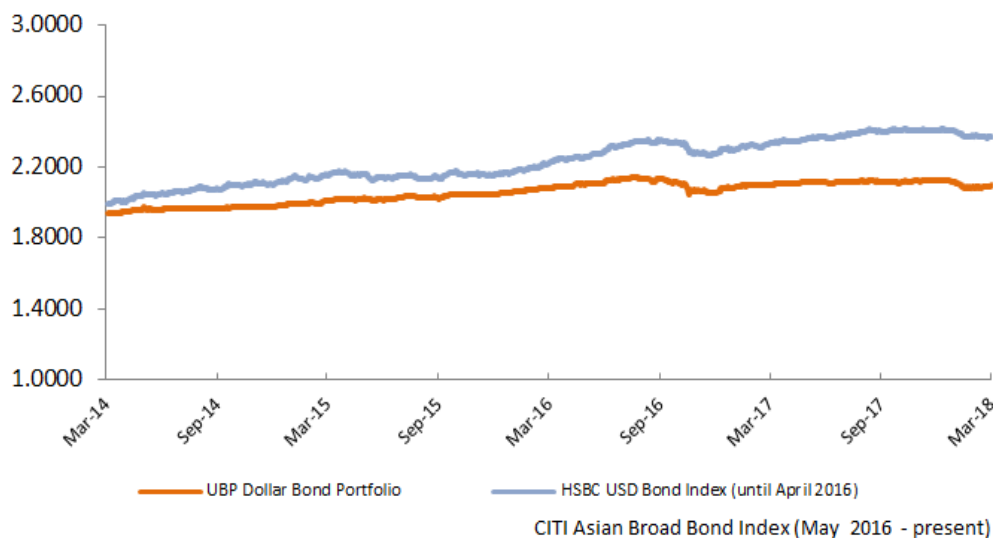

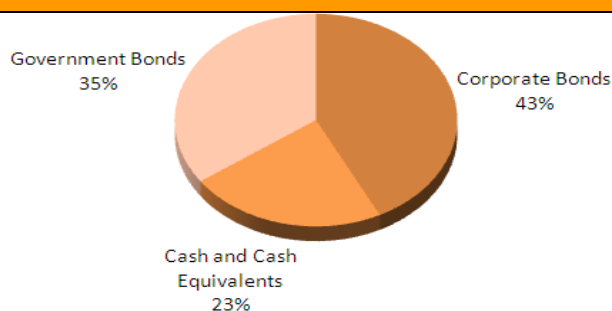

**RELATED PARTY TRANSACTIONS**

The fund has time deposits with UnionBank of the Philippines amounting to USD 958,122.01. This investment outlet was approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

**OUTLOOK AND STRATEGY**

The Fed raised its rates by 25bps in their last FOMC meeting. The target band of 1.5%-1.75% was market consensus. The FED noted economic outlook to remained upbeat citing strong job gains in the recent months and lower unemployment rate. The most watched central bank maintained three more hikes this year (to 2.1%) and projected a steeper path of hikes for 2019 (to 2.9% vs prev 2.7%) and 2020 (to 3.4% vs prev 3.1%). The Fed also projected inflation to be slightly above its target of 2% by 2020.

Trade wars and technological data breaches were the main drivers for the month of March. Global investors sparked interest in safe haven bonds as UST yields reached month low of 2.73% coming from highs of 2.89%. The US yield curve flattened further as the gap between the long term rates and short term rates narrowed. On the local front, ROP prices somehow followed suit and recovered from year to date lows. ROP 42's rose from YTD low of 93 to 96 while the benchmark 10yr ROP 28 rose 94 to 95.50. ROP credit spreads have tightened by 7bps. We remain cautious and defensive as we expect more volatility due to uncertainties with the global market developments.
