INVESTMENT OBJECTIVE AND STRATEGY

The UnionBank Large Capitalization Philippine Equity Portfolio is a peso-denominated equity fund that uses a strategy that approximates the returns of the Philippine Stock Exchange Index (PSEi), while adding value through active stock selection. Its core investment components are large capitalization stocks listed in the PSE. Relative weights between PSEi stocks as well as opportunistic allocation into non-index issues (e.g. IPO's) may vary from time to time, depending on the investment manager's outlook on stock valuations. Research plays a central role in the development of stock valuation views of investment managers.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

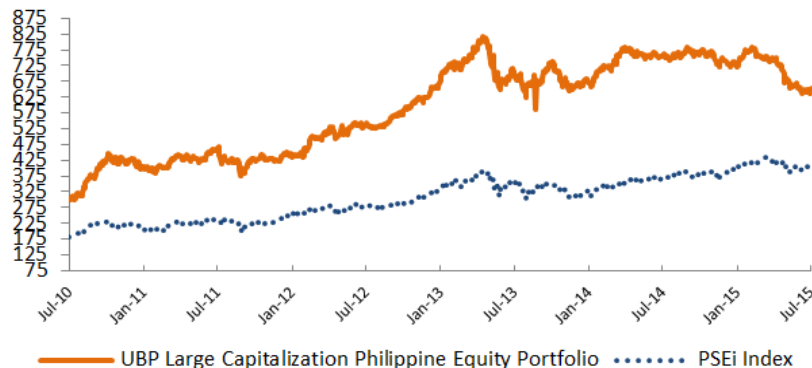

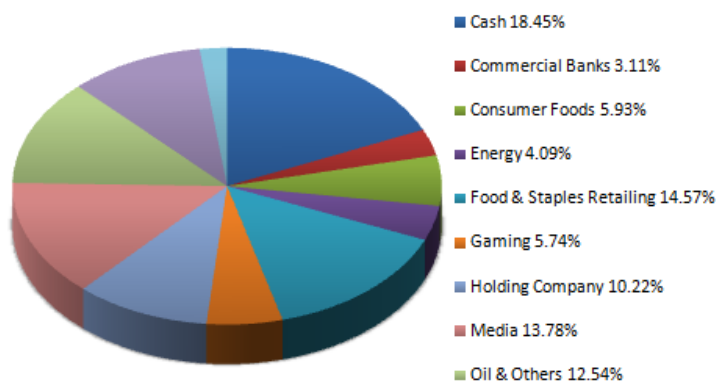

OUTLOOK AND STRATEGY

The PSE Index saw a small drop for July as it closed at 7,550, 0.19% down for the month. Various factors both foreign and domestic plagued the market as investors had to balance the Brexit concerns, the Chinese stock market plummeting and the start of the earnings season in their trades. The net effect led to a volatile market which saw the index trade within a band of 7,363.43 - 7,665.52 intra-month. On the flows side, the volume continued to slow with the direction of foreign flows is biased towards the sell side.

On corporate news, SCC suffered the biggest drop among index names on the back of the unfortunate incident that led to the deaths of some miners and the closure of their Panian mine. The Daang Hari-SLEX / Muntinlupa-Cavite Expressway was also opened by Ayala Corp as investors hope in the continued launches of the PPP projects established by the Aquino administration begin to ramp up as election season approaches. Finally, corporate earnings are beginning to come out with mixed expectations. This will be the big issue to watch with the market devoid of other catalysts in the very near term. However, we may see some positioning by funds on rate hike expectations and spending related to elections and government projects for the latter part of the year.

The fund's prospective investments include (a) Large and middle capitalization issues/securities listed in the Philippine Stock Exchange; (b) Savings/Checking accounts and/or time deposits in any bank or financial institution, including UnionBank of the Philippines; and (c) Such other tradable investment outlets/categories as the BSP may allow.
