INVESTMENT OBJECTIVE AND STRATEGY

The UnionBank Large Capitalization Philippine Equity Portfolio is a peso-denominated equity fund that uses a strategy that approximates the returns of the Philippine Stock Exchange Index (PSEi), while adding value through active stock selection. Its core investment components are large capitalization stocks listed in the PSE. Relative weights between PSEi stocks as well as opportunistic allocation into non-index issues (e.g. IPO's) may vary from time to time, depending on the investment manager's outlook on stock valuations. Research plays a central role in the development of stock valuation views of investment managers.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

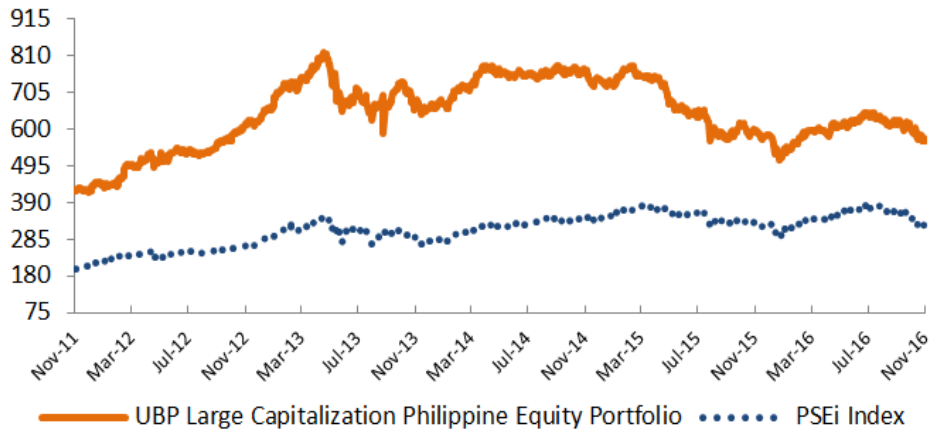

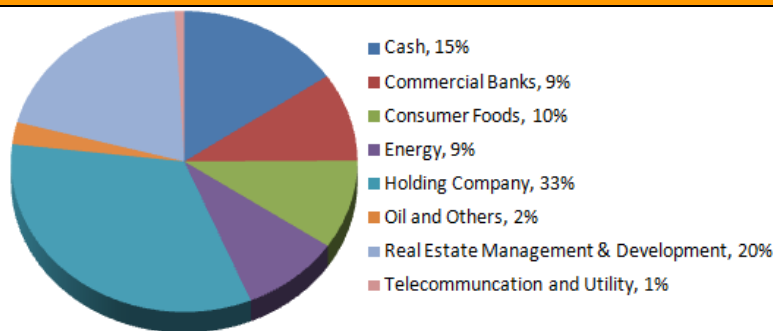

RELATED PARTY TRANSACTIONS

The fund has time deposits with City Savings Bank amounting to Php 58.23 Mn. This investment outlet was approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

The bleeding has yet to stop with the index falling for the fourth straight month to 6,781, the largest month-on-month drop of the year at -8.4%. Foreign outflows overpowered the local market reaching US\$383m, coincidentally the highest monthly outflow of the year as well. The story of the 2H16 continued with uncertainty, political risk, and underwhelming numbers from both local and foreign fronts set up the stage for a global risk off sentiment. The Trump victory in the US election implies a high probability of a rate hike given his rhetoric and potential policies. In addition, the weakening peso has exacerbated the PSEi's year-to-date drop from -2.46% in PHP terms to -7.99% in USD terms.

Without the support of strong earnings, we are now seeing the index lose its premium and come closer to its mean P/E. Many corporates were in-line with analyst expectations but because of the negative sentiment on the market and the lack of clarity in future earnings, several houses have also turned cautious on the market. We have rotated our holdings and plan to remain nimble with the ability to deploy into or take profit on liquid names.
