INVESTMENT OBJECTIVE AND STRATEGY

The UnionBank Large Capitalization Philippine Equity Portfolio is a peso-denominated equity fund that uses a strategy that approximates the returns of the Philippine Stock Exchange Index (PSEi), while adding value through active stock selection. Its core investment components are large capitalization stocks listed in the PSE. Relative weights between PSEi stocks as well as opportunistic allocation into non-index issues (e.g. IPO's) may vary from time to time, depending on the investment manager's outlook on stock valuations. Research plays a central role in the development of stock valuation views of investment managers.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

Some of the key risks associated with this Fund are listed below:

- **Market/Price Risk:** This is the possibility to experience losses due to adverse changes in market prices of securities. It is the exposure to the uncertain market value of a portfolio due to price fluctuations.
- **Liquidity Risk:** This is the possibility to experience losses due to the fund's inability to sell and convert assets into cash immediately or in instances where conversion to cash is possible but at a highly disadvantageous price.
- **Credit/Default Risk:** This is the possibility for an investor to experience losses due to a borrower's failure to pay principal and/or interest in a timely manner on instruments such as bonds, loans, or other forms of security which the borrower issued.

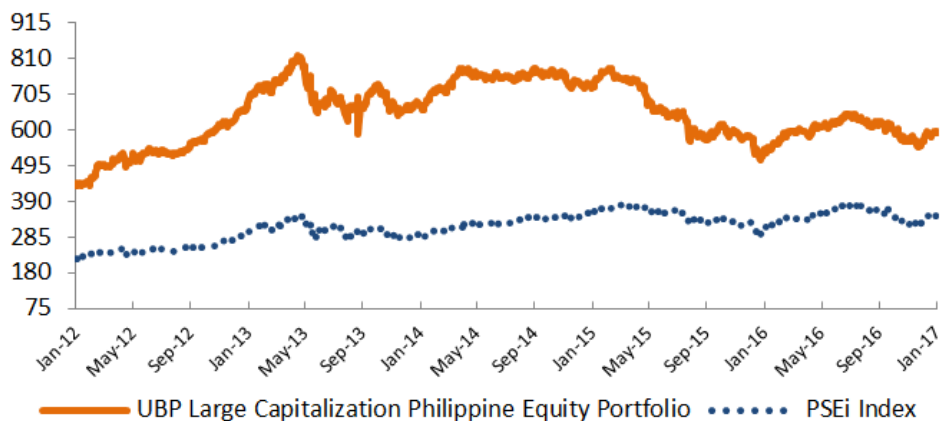

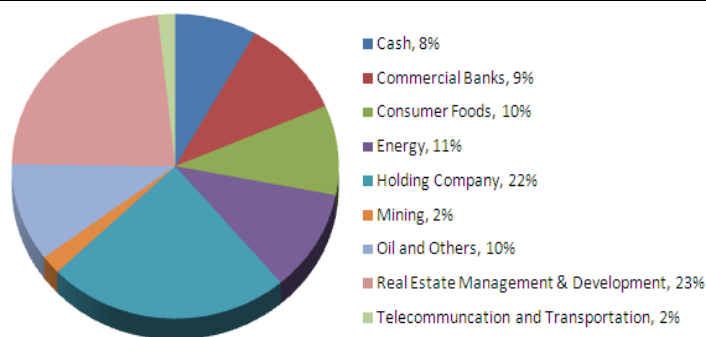

RELATED PARTY TRANSACTIONS

The fund has time deposits with City Savings Bank amounting to Php 58.39 Mn. This investment outlet was approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

The index saw strong inflows in the first week of the year to start off 2017 with a steep climb, closing 5.7% higher for January. This may primarily be due to flows as January also marked the first month of net inflows, albeit at just US\$ 5.8 M. Large cap names, particularly those which saw a weak 2016, were the biggest beneficiaries with many fund managers looking to catch up with the market's sudden rise.

We may need to observe if foreign flows are maintained given that outflows look to be on the way without any catalysts driving the market higher. A catalyst may be the passage of the first tax reform package that was submitted though this is expected to be met with opposition. We have rotated our holdings and plan to remain nimble with the ability to deploy into or take profit on liquid names.
