INVESTMENT OBJECTIVE AND STRATEGY

The UnionBank Large Capitalization Philippine Equity Portfolio is a peso-denominated equity fund that uses a strategy that approximates the returns of the Philippine Stock Exchange Index (PSEi), while adding value through active stock selection. Its core investment components are large capitalization stocks listed in the PSE. Relative weights between PSEi stocks as well as opportunistic allocation into non-index issues (e.g. IPO's) may vary from time to time, depending on the investment manager's outlook on stock valuations. Research plays a central role in the development of stock valuation views of investment managers.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. 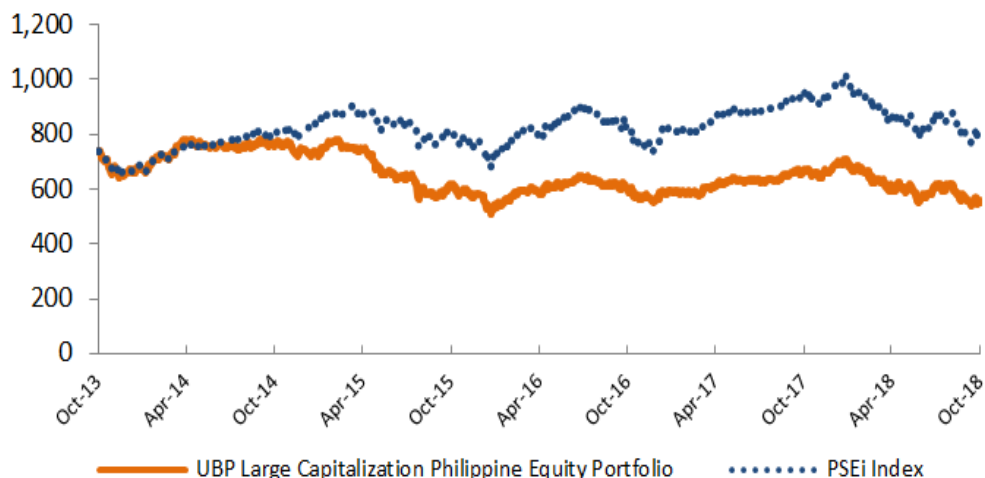

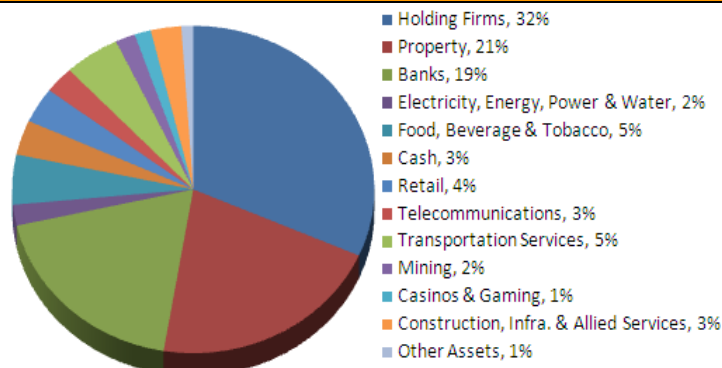

RELATED PARTY TRANSACTIONS

The fund has equity investments with Aboitiz Equity Ventures amounting to Php 25.47 Mn. This investment outlet was approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

Philippine equities continued its descent, down another 1.9% to close the month at 7,140. Almost the entire month registered foreign outflows with general volumes in the market being the lowest since September 2011. September inflation accelerated to 6.7% from 6.4% in the month prior with food prices being the main culprit. Macro forecasts have been adjusted given the shifting economic landscape. Inflation target ranges rose from 4-4.5% to 4.8-5.2% for 2018 and 2-4% to 3-4% for 2019. The GDP estimate has also been lowered from 7-8% to 6.5-6.9% for 2018. The government will need to observe rice and oil prices and act accordingly with policies addressing these inflation drivers.

3Q Earnings started coming out late in October and were generally in line. Property names, banks and a few conglomerates suffered from foreign outflows. Consumer movements were mixed but the negative effect of inflation will likely impact margins across the board to varying degrees. The majority of companies will report in November with market players watching for strong beats to offset macro concerns.
