INVESTMENT OBJECTIVE AND STRATEGY

The UnionBank Large Capitalization Philippine Equity Portfolio is a peso-denominated equity fund that uses a strategy that approximates the returns of the Philippine Stock Exchange Index (PSEi), while adding value through active stock selection. Its core investment components are large capitalization stocks listed in the PSE. Relative weights between PSEi stocks as well as opportunistic allocation into non-index issues (e.g. IPO's) may vary from time to time, depending on the investment manager's outlook on stock valuations. Research plays a central role in the development of stock valuation views of investment managers.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. Clients are advised to read the Declaration of Trust/Plan Rules of the Fund, which may be obtained from the Trustee, before deciding to invest.

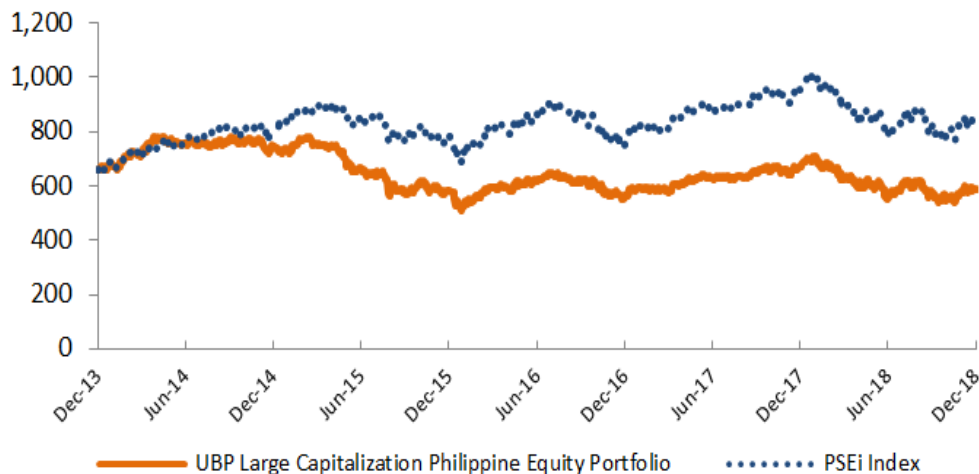

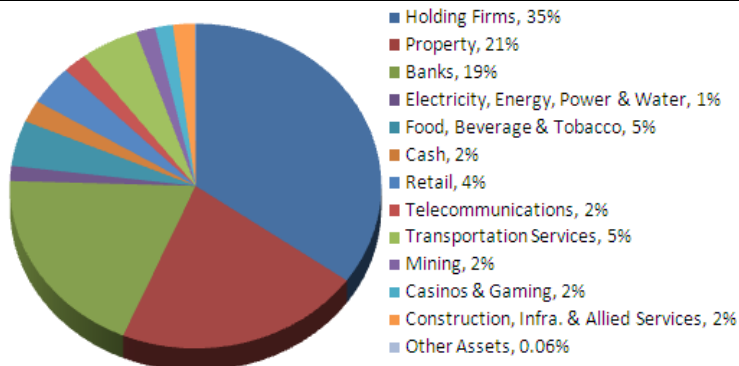

RELATED PARTY TRANSACTIONS

The fund has equity investments with Aboitiz Equity Ventures and time deposits with Unionbank of the Philippines amounting to Php 30.78 Mn, and Php 3.68 Mn, respectively. These investment outlets were approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

The supposed Santa rally continued, but perhaps not as strong as what some investors would've hoped, as the market ran up another +1.3% MoM to close the index -12.8% for the year 2018. The local market was hammered with concerns on the US China trade war, TRAIN package 1, rising inflation, twin deficit, and weak currency over the year which caused significant outflows even with extraordinary one-off blocks, the net outflow amounting to US\$ 1.1bn.

CPI eased for the month of November from 6.7% down 6.0% due to drop in food prices. Current account deficit was at 3.7%, which may further push up interest rates and weaken the currency down the line. However, foreign interest may ramp up as the election year approaches. Improving inflation figures and dissipating trade war concerns may be the catalysts for more inflows.
