INVESTMENT OBJECTIVE AND STRATEGY

The UnionBank Dividend Play Equity Portfolio is a peso-denominated fund that invests in dividend yielding equity securities listed in the Philippine Stock Exchange Index (PSEi). The portfolio has an equity-income/growth strategy that invests in stocks of well established companies that have a history of regular dividend payments and potential for capital appreciation. Income strategy counteracts the volatility of the portfolio.

CLIENT SUITABILITY

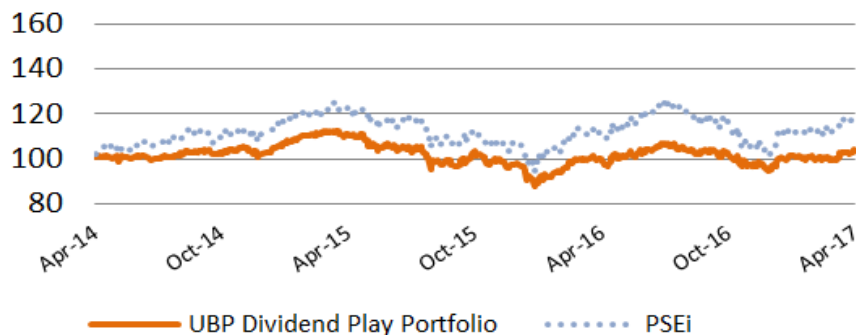

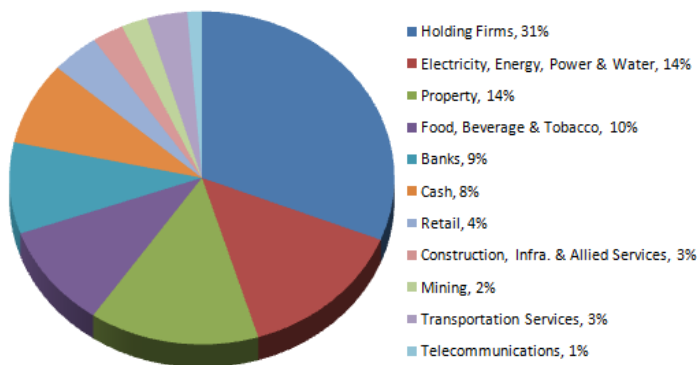

RELATED PARTY TRANSACTIONS

The fund has equity investments with Aboitiz Equity Ventures and Aboitiz Power and time deposits with City Savings Bank amounting to Php 1.83 Mn, Php 7.56 Mn and Php 12.42 Mn respectively. These investment outlets were approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

The local index spiked 4.8% for the month, ending at 7,661 with foreign net inflows coming back into the market. Bargain hunting may be cited as a possible reason for this as well as potential optimism on the passage of the tax reform. Earnings growth for 2016 was an increase 14% driven by the gaming sector coming off large losses in the previous year. Continued foreign inflow should buoy the market but the steepness of this may be unwarranted if either Q1 disappoints or there are any setbacks on the passage of the reforms and delays on the infrastructure roll out.

Earnings reports are trickling in for Q1 but few have been remarkable so far. Investors are still closely watching the progress of the government's tax reform package. We are relatively close to being fully invested but we plan to remain nimble with the ability to deploy into or take profit on liquid names.
