INVESTMENT OBJECTIVE AND STRATEGY

The UnionBank Dividend Play Equity Portfolio is a peso-denominated fund that invests in dividend yielding equity securities listed in the Philippine Stock Exchange Index (PSEi). The portfolio has an equity-income/growth strategy that invests in stocks of well established companies that have a history of regular dividend payments and potential for capital appreciation. Income strategy counteracts the volatility of the portfolio.

CLIENT SUITABILITY

A client profiling process should be performed prior to participating in the Fund to guide the prospective investor if the Fund is suited to his/her investment objectives and risk tolerance. 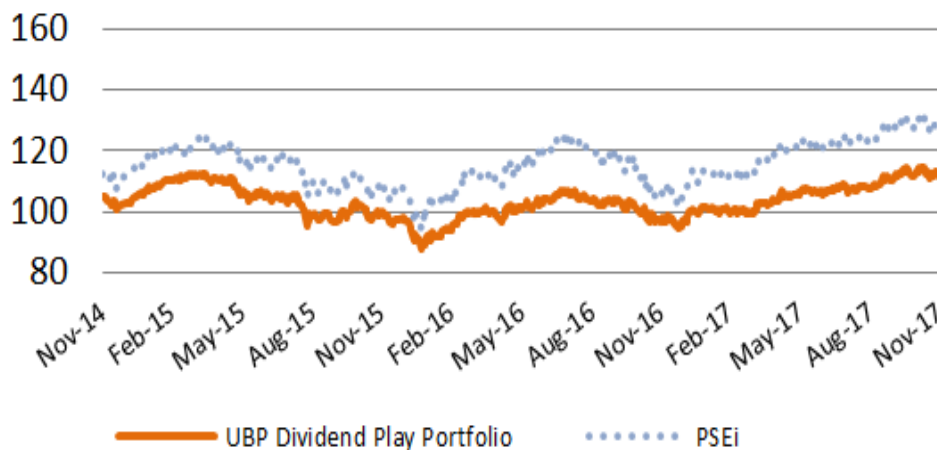

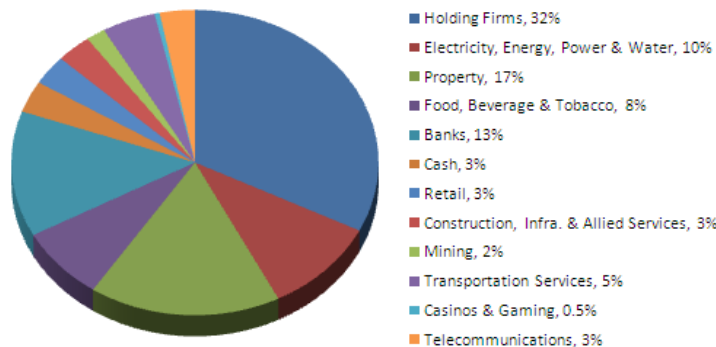

RELATED PARTY TRANSACTIONS

The fund has equity investments with Aboitiz Equity Ventures and Aboitiz Power amounting to Php 3.28 Mn and Php 2.47 Mn, respectively. These investment outlets were approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

OUTLOOK AND STRATEGY

The index lost steam in November with a 1.3% drop despite the Philippines marking a 6.9% growth in GDP. The local market experienced foreign outflows along with the rest of the region. The drop was broad based despite earnings results coming out mostly in line with analysts' expectations.

The Senate was able to pass their version of Package 1. However, this still needs to go through the Bicameral Conference for reconciliation with the House version. The government has been vocal in their belief that this will be passed within the year and with the market softening with only a month left in 2017, it may be the catalyst needed for foreign funds to trickle back in.

We are fully invested but we plan to remain nimble with the ability to deploy into or take profit on liquid names.
