

UnionBank Shell Power Card Birthday Treat Promo

Overview

1. The UnionBank Shell Power Birthday Treat Promo (“Promo”) will run from February 1, 2026 – January 31, 2027 (“Promo Period”).
2. The Promo is open to existing **principal UnionBank Shell Power Gold or UnionBank Shell Power Platinum** cardholders.
3. UnionBank Shell Power Gold or UnionBank Shell Power Platinum cardholders shall be entitled to one (1) free drink or pastry. A Birthday Treat, in the form of a pastry or drink offered at participating Shell deli2go or Shell Café branches, includes but is not limited to the following:

Pastry	Drink
Sausage Roll	Americano 12oz
Spam & Egg Turnover	Hot Chocolate 12oz

Note: Redeemable Birthday Treat is subject to availability at the time of the redemption

4. The cardholder will receive an SMS on their registered mobile number with UnionBank during their birth month.
 - a. The cardholder must show the original SMS from UnionBank. SMS should not be a forwarded message nor a screenshot.
 - b. The Cashier is required to view the SMS and to delete the SMS upon receipt of the promo.
5. To claim the Birthday Treat, the cardholder must present the SMS from UnionBank, including their UnionBank Shell Power Card and 1 valid ID bearing their birthdate to a participating Shell deli2go or Shell Café branch. The UnionBank Shell Birthday Treat may only be claimed once and cannot be reused upon claiming of the Birthday Treat.
6. The cardholder can redeem the birthday treat within 20 days from receipt of the SMS.
7. The UnionBank Shell Power Birthday Treat may not be converted to or paid out in cash.
8. UnionBank and Shell may discontinue the granting of the Birthday Treat to the cardholder if applicable law, regulation, or policy restricts the continued granting of such gift / reward.

General Terms and conditions

1. Incumbent government officials or employees, whether elected or appointed, corporate accounts and US persons (i.e., a citizen or lawful resident, green card holder of the United States of America) are **not eligible** to participate in the Promo.
2. Promo offer cannot be used in conjunction with other Unionbank promotional offers, privileges, or VIP cards. Discounts and privileges are not exchangeable or convertible to cash or other goods and services nor are they allowed as payment for the card dues.
3. The Bank reserves the right to withhold granting of rewards where there is a suspected or suspicious customer activity that requires further investigation.
4. If a prize or benefit has already been awarded and the violation or fraudulent activity is discovered after being awarded, the Bank shall have the right to clawback or chargeback the full cost of the credit earned.
